The investment objective of the Dimensional US Real Estate ETF (the "US Real Estate ETF" or "Portfolio") is to achieve long-term capital appreciation.

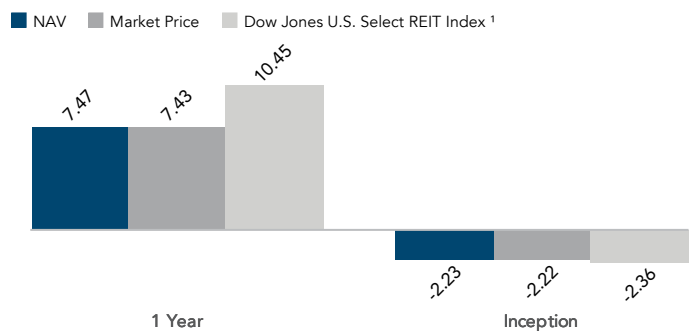
