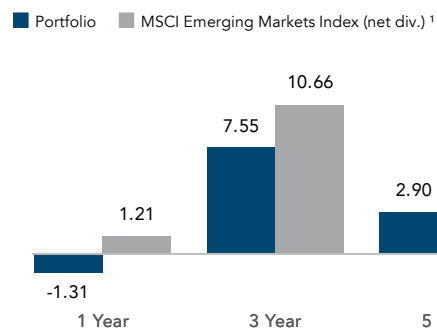
PRINCIPAL RISKS
