The investment objective of the International Sustainability Core 1 Portfolio is to achieve long-term capital appreciation.

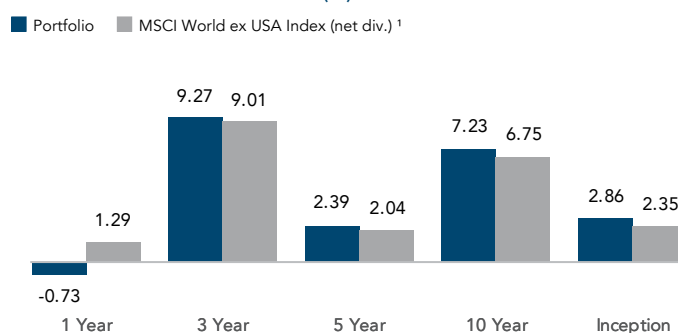
PRINCIPAL RISKS
