The investment objective of the Global Equity Portfolio is to achieve long-term capital appreciation.

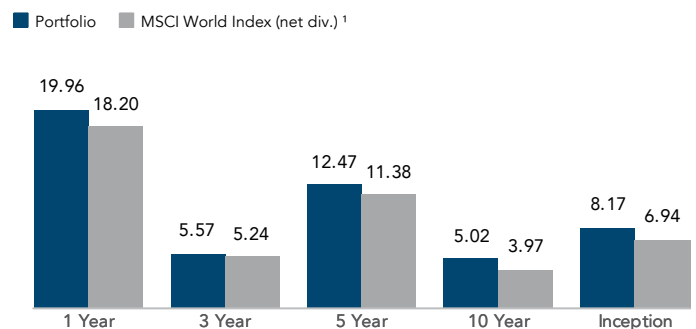
