The investment objective of the World ex U.S. Targeted Value Portfolio is to achieve long-term capital appreciation.

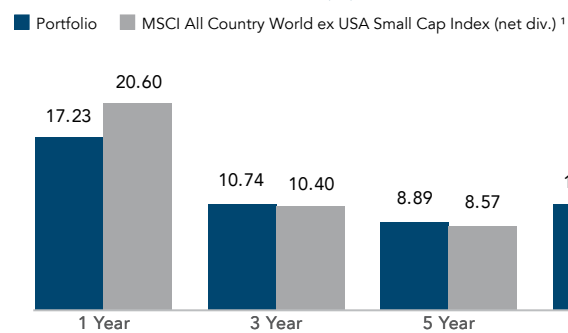
## PRINCIPAL RISKS
