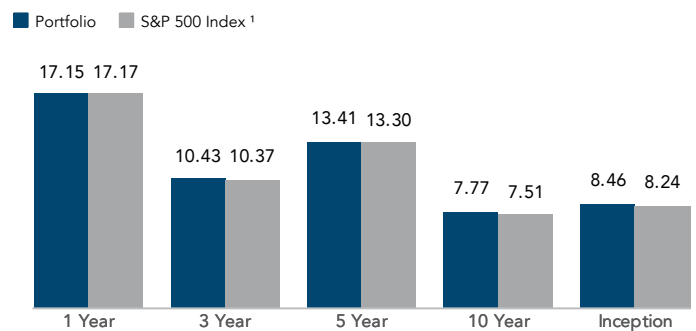
### INVESTMENT OBJECTIVE
