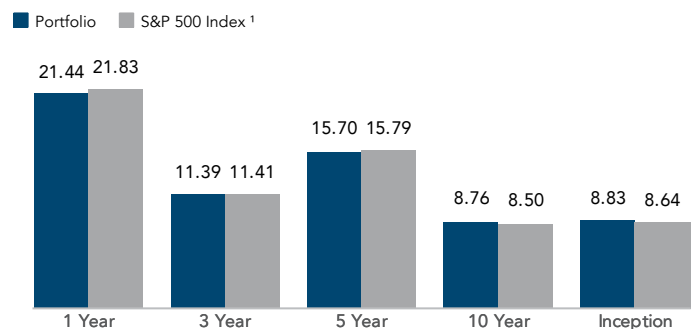
INVESTMENT OBJECTIVE
