The investment objective of the VA International Small Portfolio is to achieve long-term capital appreciation.

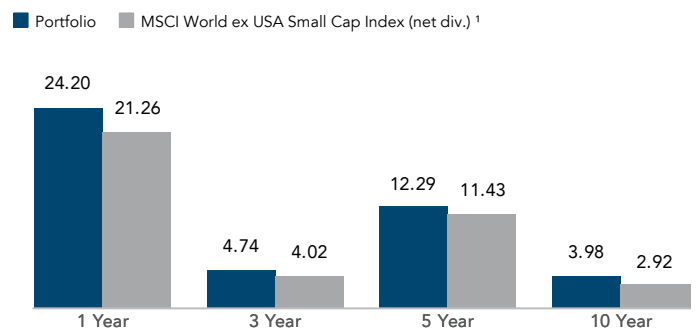
PRINCIPAL RISKS
