The investment objective of the DFA International Small Cap Value Portfolio is to achieve long-term capital appreciation.

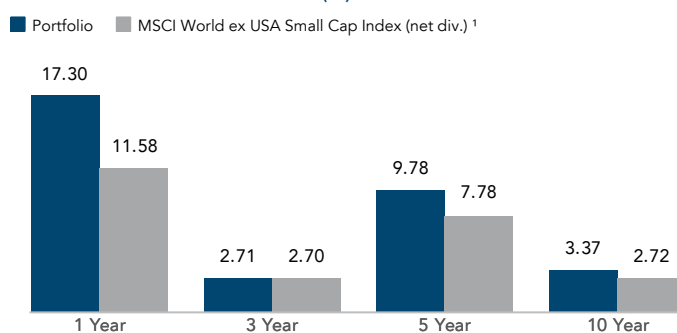
## PRINCIPAL RISKS
