## PRINCIPAL RISKS

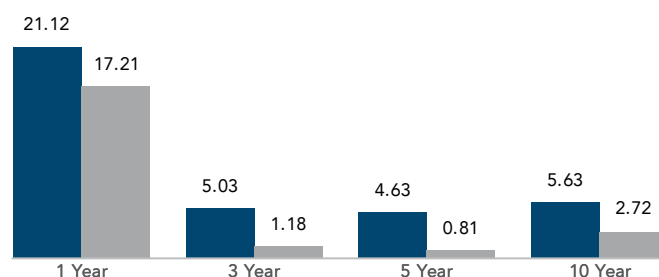
