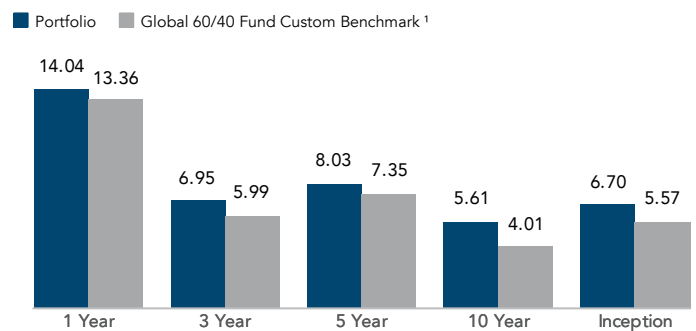
## INVESTMENT OBJECTIVE
