## INVESTMENT OBJECTIVE

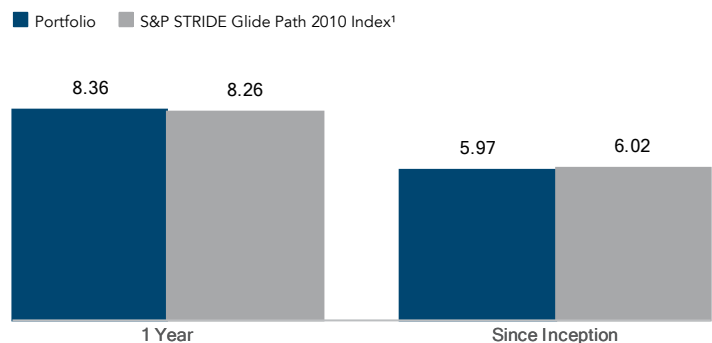

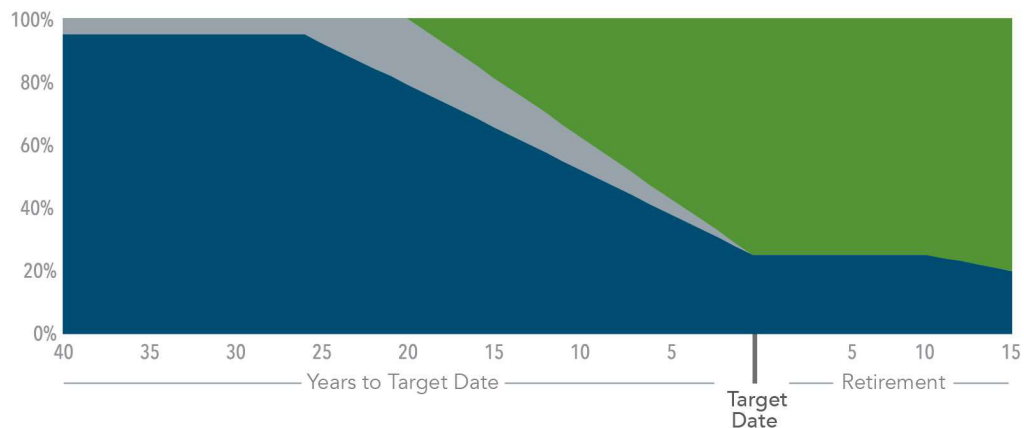
