## INVESTMENT OBJECTIVE

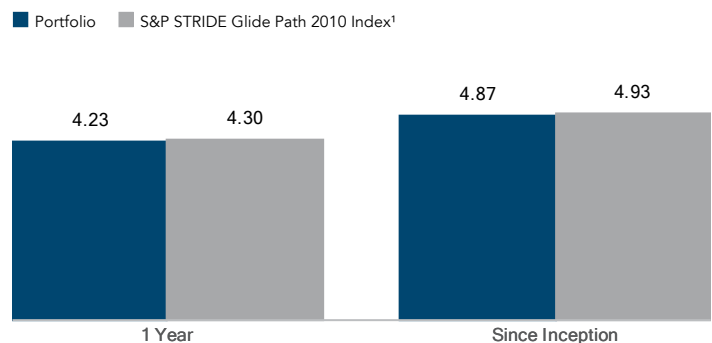

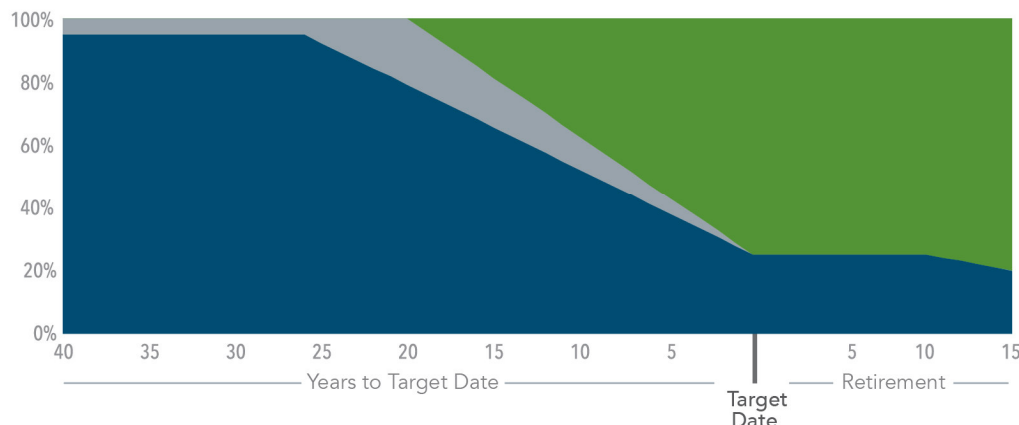
