## INVESTMENT OBJECTIVE

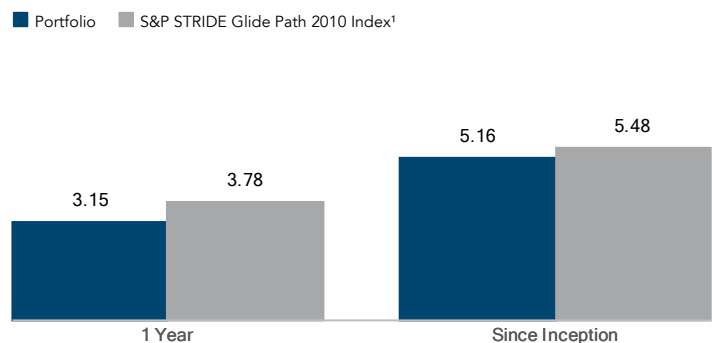

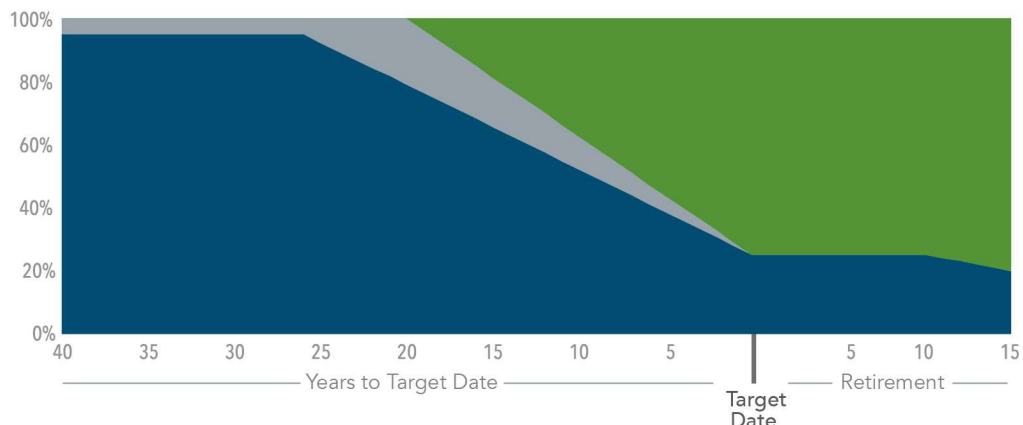

The S&P Shift to Retirement Income and Decumulation (STRIDE) Index Series comprises twelve multi-asset class indices, each corresponding to a particular target retirement date.
