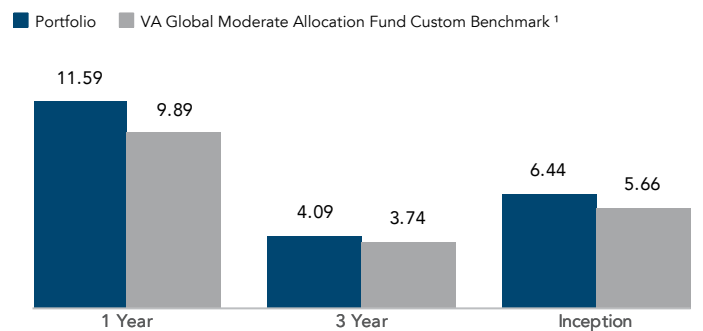
INVESTMENT OBJECTIVE

The DFA VA Global Moderate Allocation Portfolio is a "fund of funds," which means that the Portfolio uses its assets to purchase other mutual funds managed by Dimensional Fund Advisors LP.
