INVESTMENT OBJECTIVE

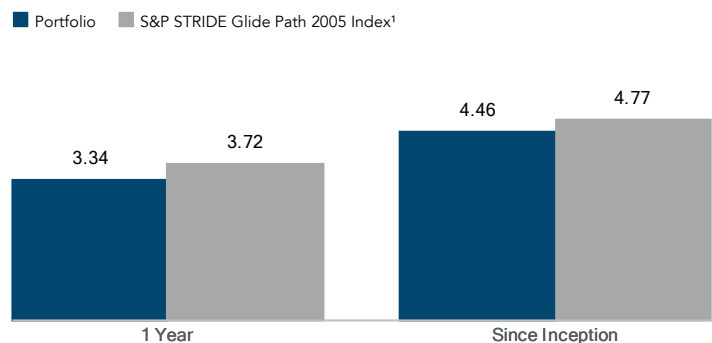

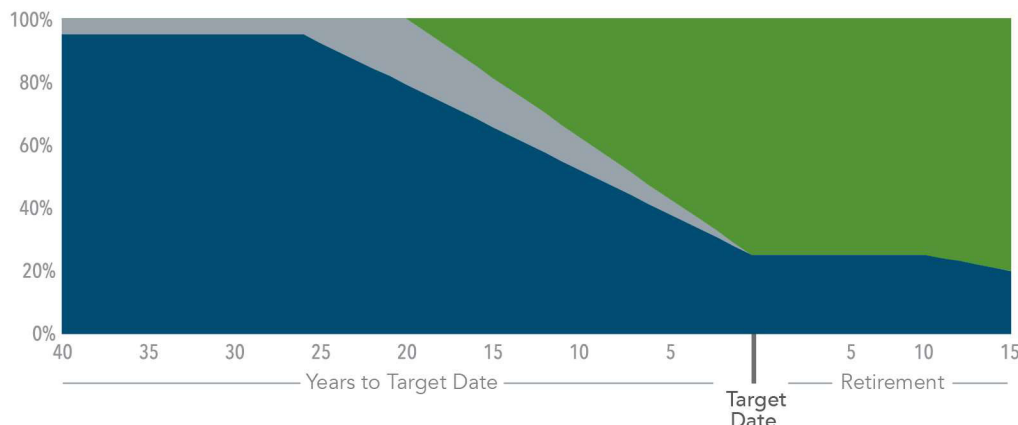
