The investment objective of the DFA Intermediate Government Fixed Income Portfolio is to earn current income consistent with preservation of capital.

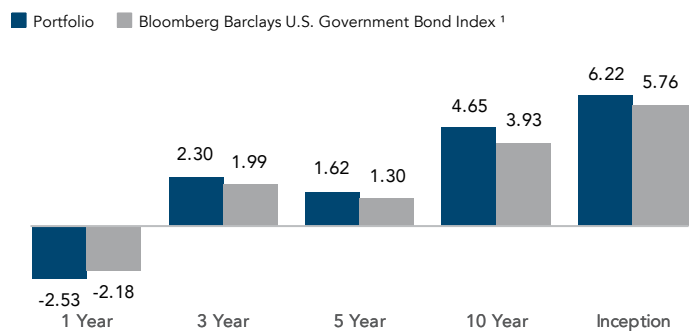
## PRINCIPAL RISKS
