The investment objective of the DFA Municipal Bond Portfolio is to seek to provide current income that is exempt from federal personal income tax.

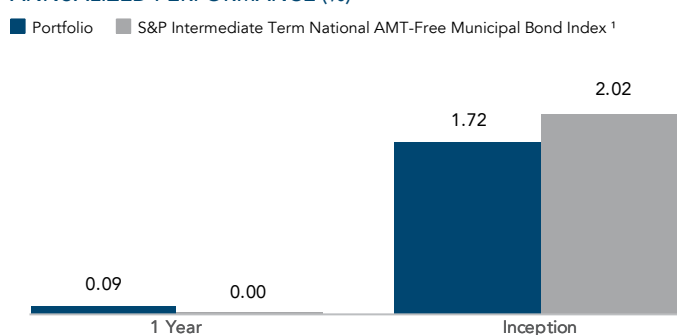
PRINCIPAL RISKS
