INVESTMENT OBJECTIVE

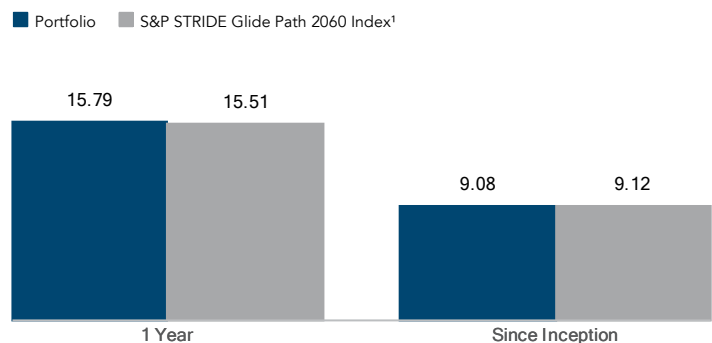
The investment objective of the Dimensional 2060 Target Date Retirement Income Fund is to provide total return consistent with the Portfolio's current asset allocation. Total return is composed of income and capital appreciation.

PRINCIPAL RISKS

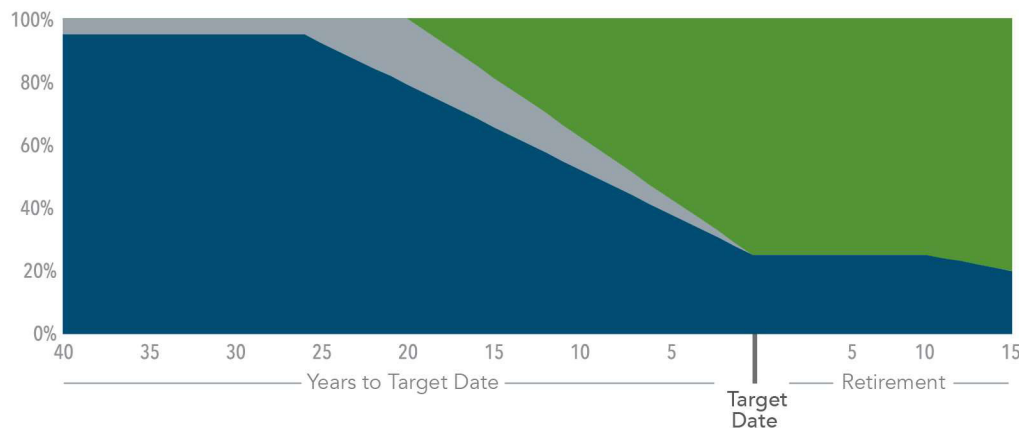

¹ Due to the unavailability of returns data for the S&P STRIDE Indices prior to 1/12/16, benchmark performance from the fund's inception on 11/2/15 and ending 1/11/16 is that of a blend of the S&P Global Broad Market Index, Citigroup WGBI 1-3 Year (hedged), S&P 1-5 Yr US TIPS Index, S&P 7-10 Yr US TIPS Index, and S&P 30 Yr US TIPS Index in weights similar to the fund's allocation to those respective asset classes. The S&P Shift to Retirement Income and Decumulation (STRIDE) Index Series comprises twelve multi-asset class indices, each corresponding to a particular target retirement date. The allocations of each S&P STRIDE index may consist of a group of indices covering global equities, global fixed income, and U.S. TIPS, with allocation to TIPS increasing, and the allocation to global equities decreasing, as the target retirement date approaches.
