The investment objective of the VA International Value Portfolio is to achieve long-term capital appreciation.

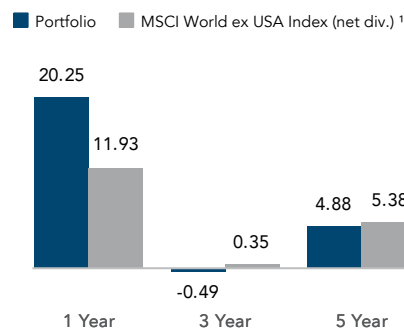
