The investment objective of the VIT Inflation-Protected Securities Portfolio is to provide inflation protection and earn current income consistent with inflation-protected securities.

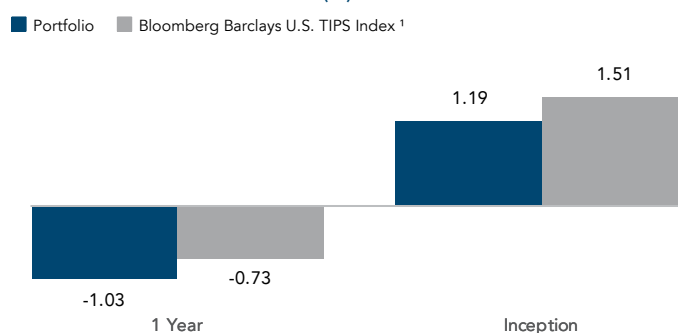
## PRINCIPAL RISKS
