The investment objective of the International Small Cap Growth Portfolio is to achieve long-term capital appreciation.

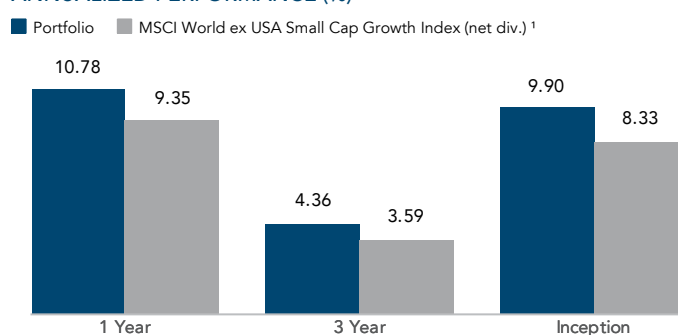
