The investment objective of the DFA Intermediate-Term Municipal Bond Portfolio is to seek to provide current income that is exempt from federal personal income tax.

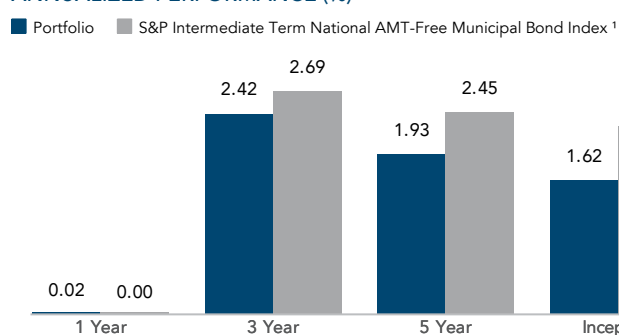
