The investment objective of the VA U.S. Targeted Value Portfolio is to achieve long-term capital appreciation.

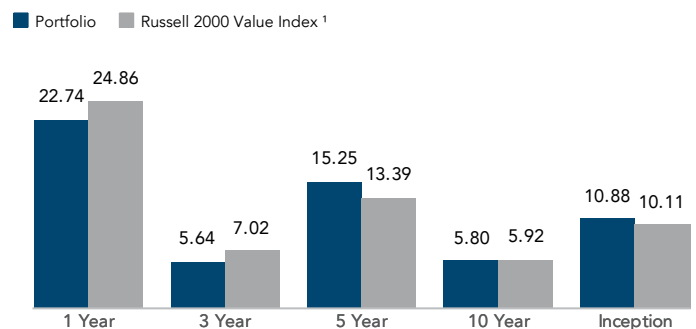
