The investment objective of the International Core Equity Portfolio is to achieve long-term capital appreciation.

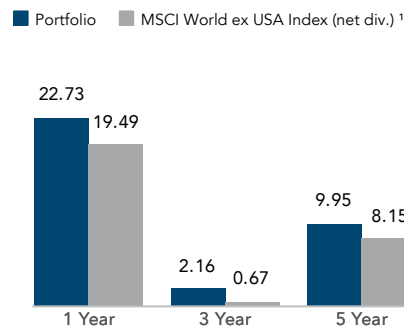
