The investment objective of the U.S. Core Equity 1 Portfolio is to achieve long-term capital appreciation.

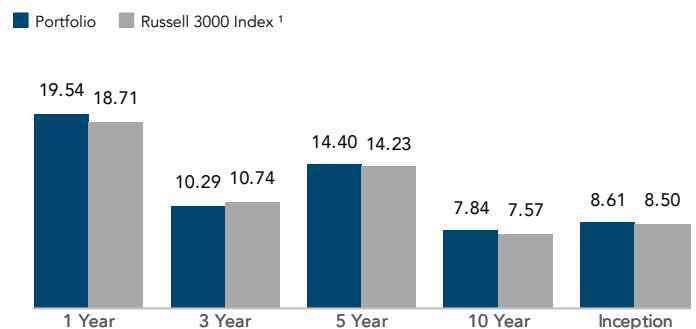
