The investment objective of the Emerging Markets Social Core Equity Portfolio is to achieve long-term capital appreciation.

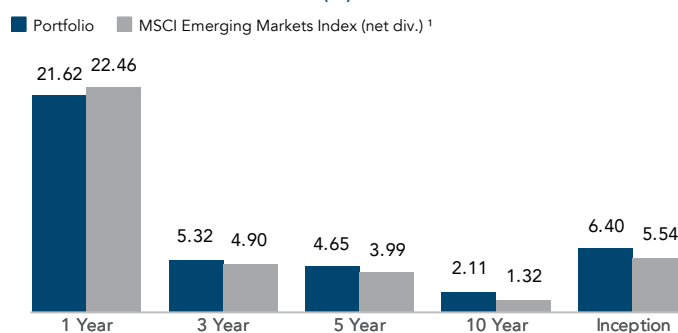
PRINCIPAL RISKS
