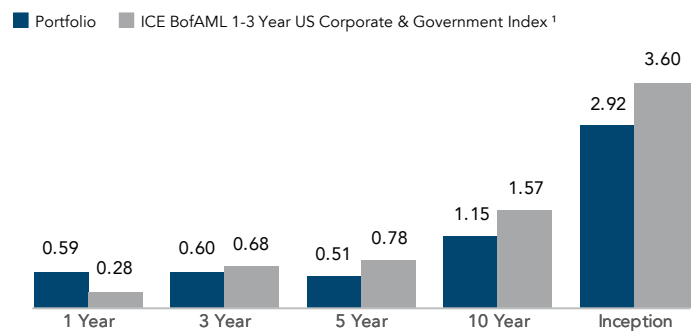
## PRINCIPAL RISKS
