## INVESTMENT OBJECTIVE

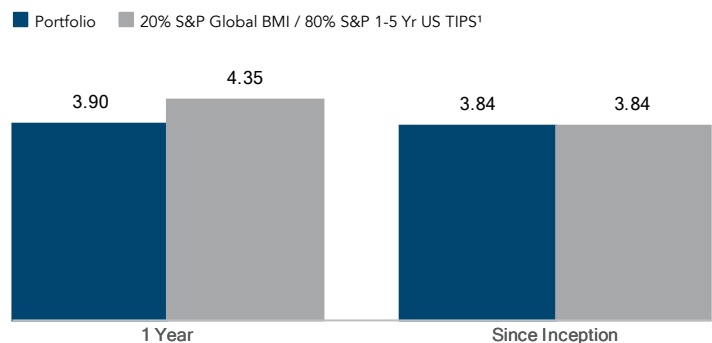
