## INVESTMENT OBJECTIVE

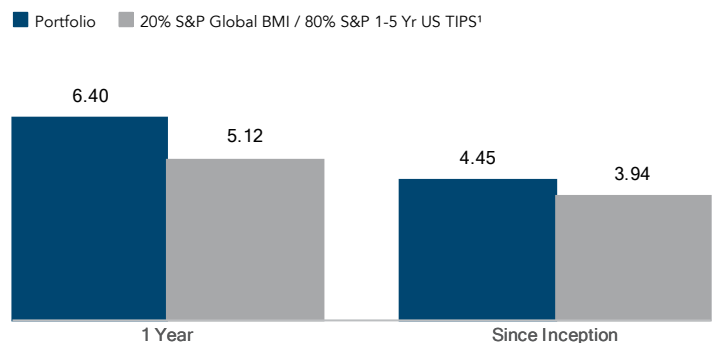
