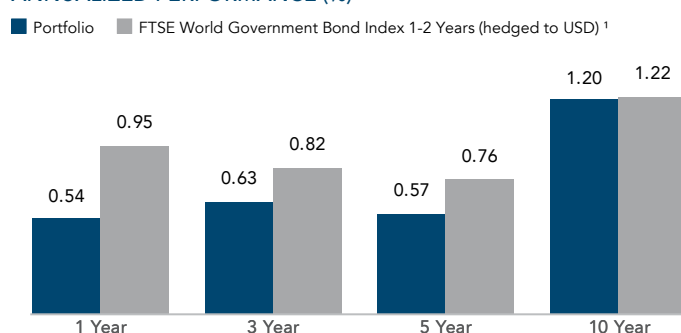
### PRINCIPAL RISKS
