INVESTMENT OBJECTIVE

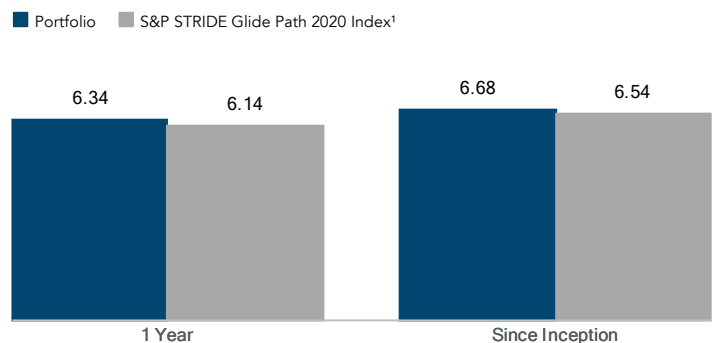
The investment objective of the Dimensional 2020 Target Date Retirement Income Fund is to provide total return consistent with the Portfolio's current asset allocation. Total return is composed of income and capital appreciation.

PRINCIPAL RISKS

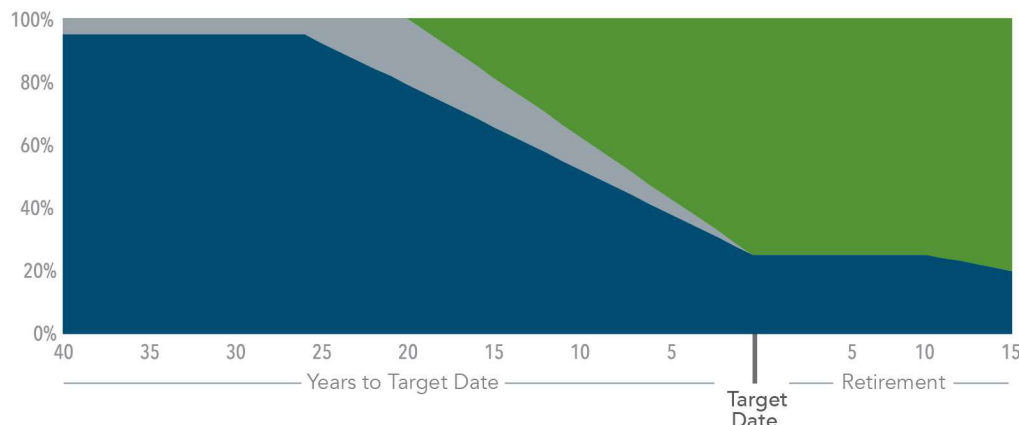

The S&P Shift to Retirement Income and Decumulation (STRIDE) Index Series comprises twelve multi-asset class indices, each corresponding to a particular target retirement date.
