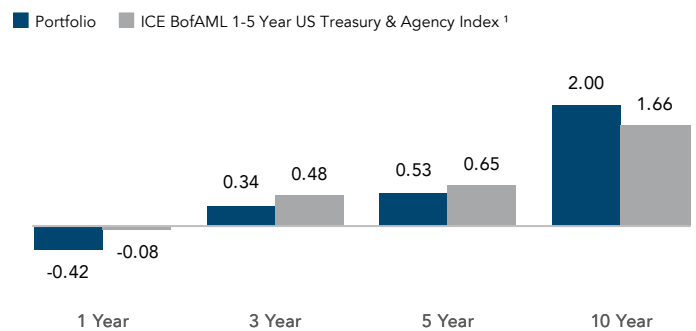
PRINCIPAL RISKS
