The investment objective of the DFA Short-Duration Real Return Portfolio is to seek inflation protection and maximize total returns.

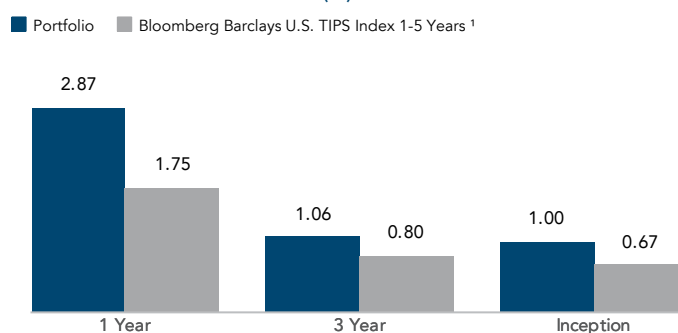
PRINCIPAL RISKS
