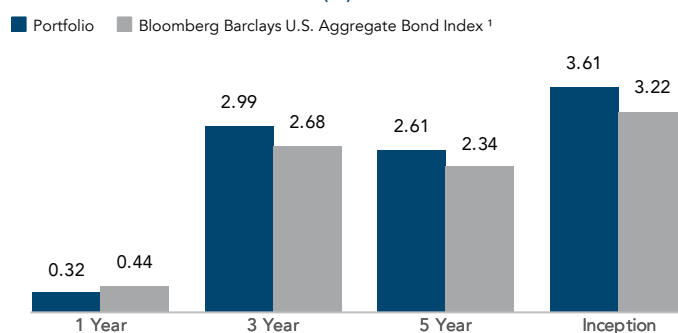
PRINCIPAL RISKS
