INVESTMENT OBJECTIVE

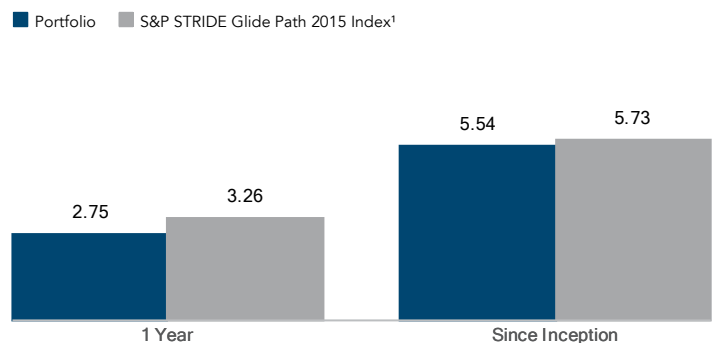

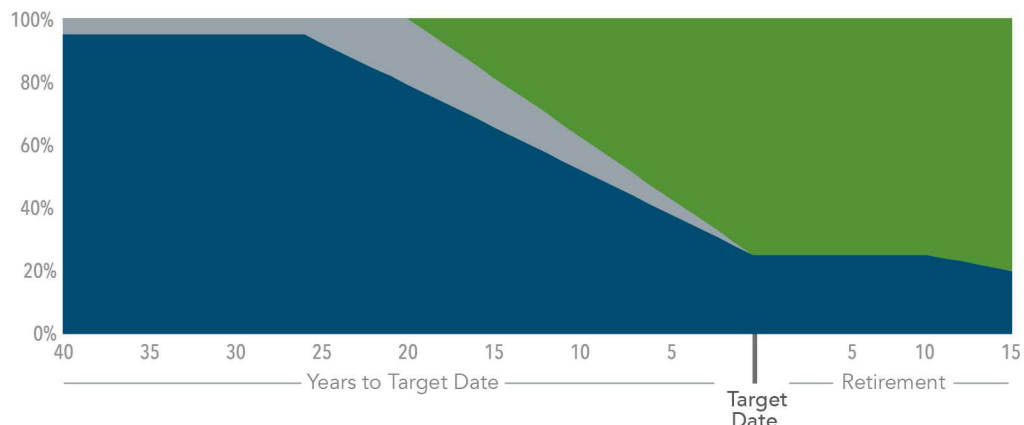
