## INVESTMENT OBJECTIVE

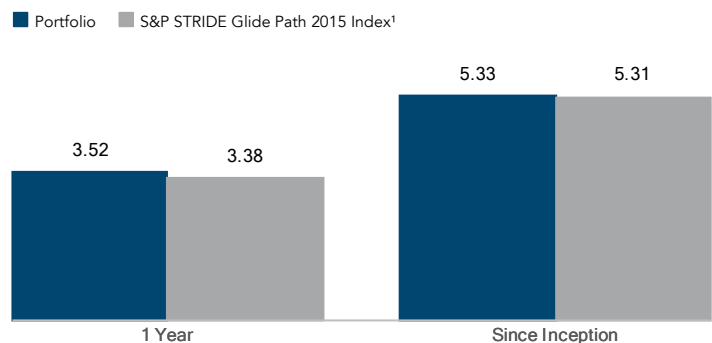

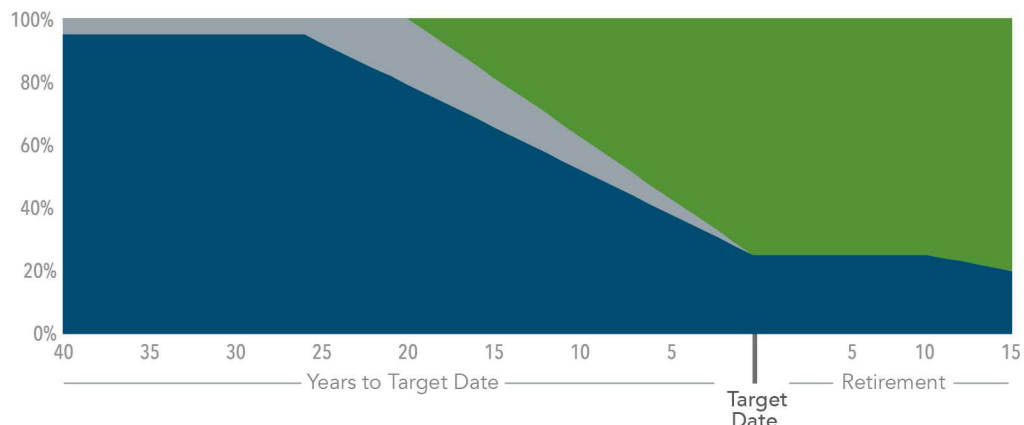
