## INVESTMENT OBJECTIVE

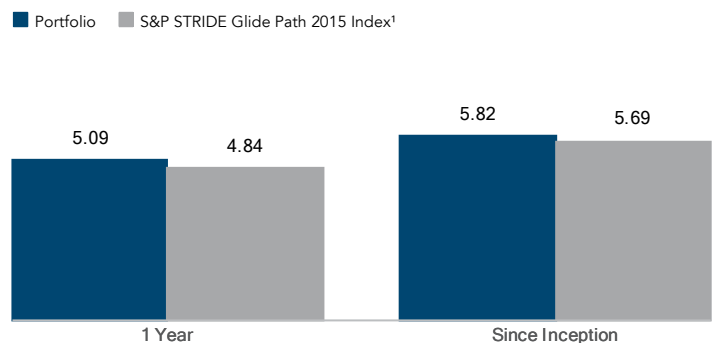

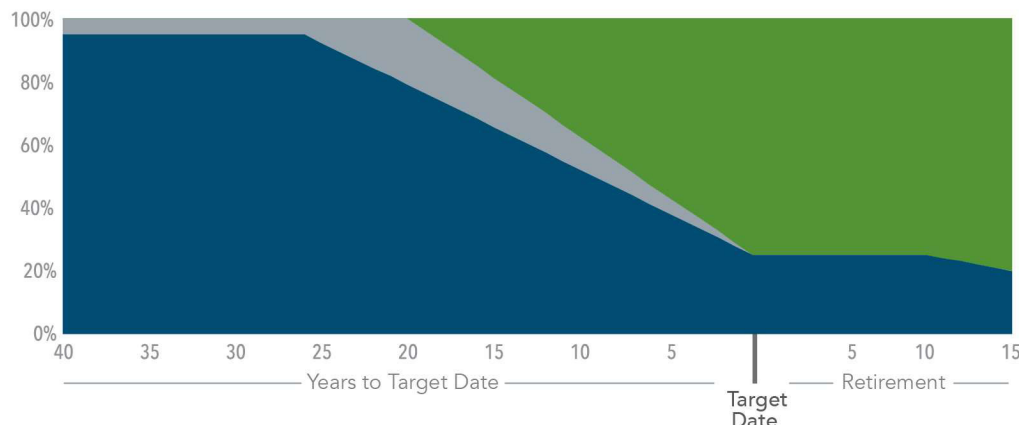
