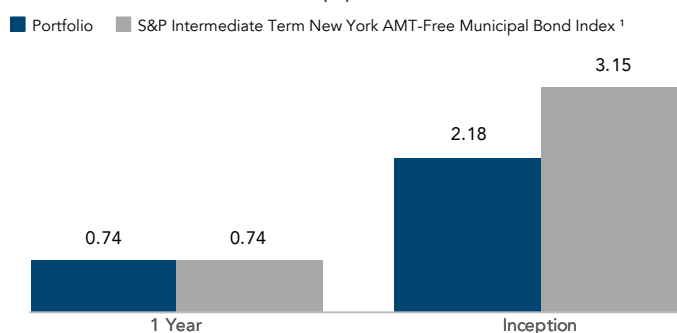
PRINCIPAL RISKS
