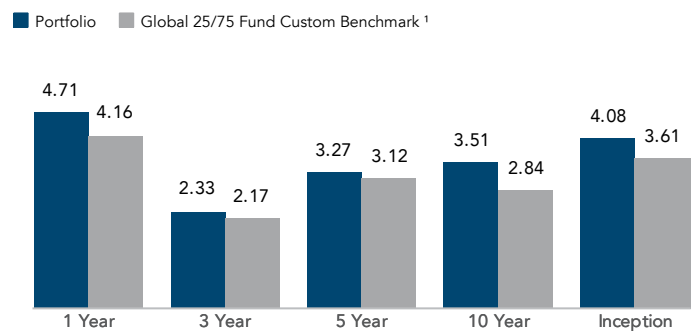
INVESTMENT OBJECTIVE
