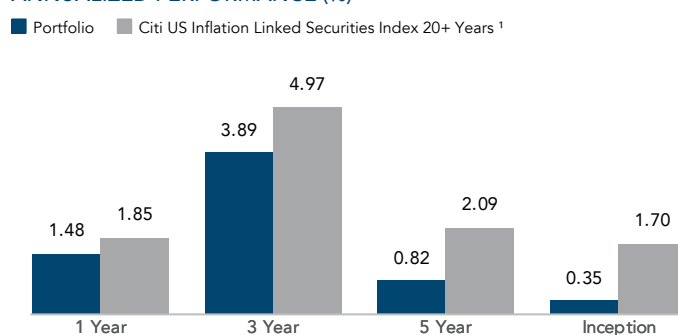
PRINCIPAL RISKS
