The investment objective of the DFA Social Fixed Income Portfolio is to seek to maximize total returns. Total return is comprised of income and capital appreciation.

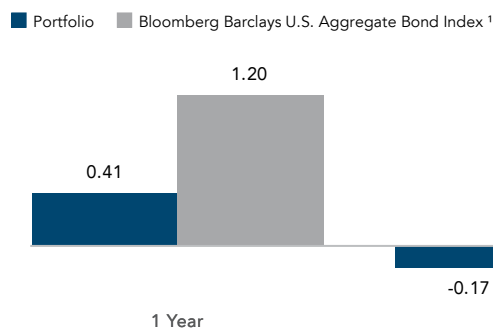
## PRINCIPAL RISKS
