The investment objective of the International Vector Equity Portfolio is to achieve long-term capital appreciation.

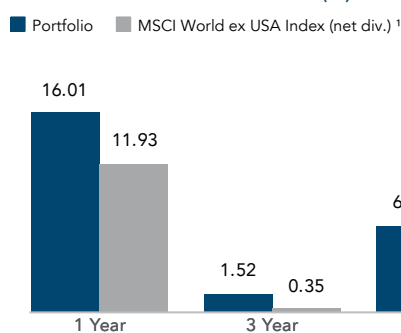
