The investment objective of the DFA Municipal Real Return Portfolio is to seek inflation protection and to provide current income from municipal securities.

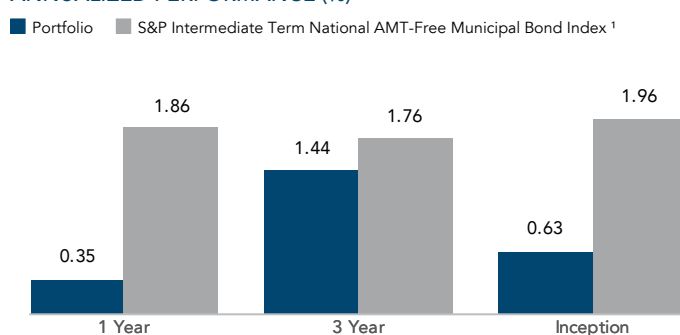
PRINCIPAL RISKS
